Huai ban ah demand tuamtuan i neihte uh salpha site luang toh kisai; relief and rehabilitation toh kisai; security khauhsem a koihi ding; Meitei radical groups Arambai Tenggol leh Meitei Leepun te kintak a sukbei ding; nek leh tak supply a tanlouh ding leh internet service kintaka paisak ding; pawlam toh kikawmtuahna ding in helicopter service a om ding; Imphal a nasem state leh central govt a nasemte dinmun toh kisai; schools, institute leh universities a student te board dang leh university dang a suan ding; Imphal exam center te district headquarters a suan ding; singtangmite tellou leh theihpihlou a Imphal a court hearing paipai pen khawlsak ahih ding; Imphal jail a tang singtangmite hinna lauhhuai ahih ziaak a transfer ahih kei leh khakhiaak ahih ding uh chihthe genkhiaakna Pu Ginza in nei hi. Relief toh kisai in Manipur a di 30,000 metric tonnes relief material govt in hon khakta ahih dan gen a, hiai lak akipan 20,000 metric tonnes pen singtangmite a ding ahi chi hi. Tua ban ah District Hospital ah doctor kitasam ahih ziaak in Delhi akipan Doctor team 8 hong pai ding ahi chi hi. Helicopter service toh kisai le ngaihtuah a om ahih dan gen hi. Court hearing leh education lam a na buaina uh ka thei ua, lampi khat ka hon ngaihtuah ding uh chi hi. Sihna leh liamna tuakte zangnadopna le amau bank account ah direct a piak hi ding ahi chi hi.

Hiai toh kisai Pu Ginza in Pu Amit Shah meeting zoh in dotna bawl a, na chih bang in kou muanna bawl leng ule, Meitei ten hon attack zel uleh ka ki-defend uh ngai ding ahi ahih leh Pu Amit Shah in tu nitak mahmah in border line ah security double sak di ka hi chi in dawng hi.

Rumours tam theilua ahih man in thuchian kanna ding in helpline nih Imphal leh Lamka ah koihi ding ahih dan gen hi. Hiai buaina ziaak a sihna leh liamna tuakte PM Narendra Modi leh amah in a thuakpih dan gen in meeting zoh in om hi.
